SERVICE CONTRACT

This agreement is made and entered into on ____ day of _____ 20__ Between _____
_____ (mare owner) and Open Range the owner of stallion Kool Rascal Reg. No.
Q36472. The mare owner is the owner of _____ (Name of
mare). Reg. No. _____, a copy of whose registration papers are attached. The parties hereto
contract for the servicing of the said mare by the said stallion for the **20__** breeding season, which ends
on **31st January, 20__** on the following terms and conditions.

1. The parties hereto contract for the servicing of the said mare for the fee of \$1,100 (G.S.T inclusive). The mare owner has paid the stallion owner a non- refundable booking fee of \$200.00 the receipt of which is acknowledged.
2. Agistment will be charged from the date of arrival of the mare at the stud until date of departure inclusive at the sum of \$5.00 per day. (Agistment subject to current feed prices and subject to change).
3. The mare will be drenched upon arrival and thereafter every six to eight weeks. Hoof care will be provided by the stallion owner as and when required at the mare owner expense. All expenses incurred for the mare will be paid by the mare owner.
4. All veterinary expenses incurred for the mare, including pregnancy tests, will be paid by the mare owner. The mare must be accompanied by a current veterinary certificate stating that the mare is free from any contagious diseases. Stallion owner may at any time and at such expense to the mare owner have the mare examined for any such diseases or for any purpose whatsoever by a veterinarian nominated by the stallion owner: Stallion owner may treat the mare as deemed necessary by the veterinarian or reject the mare whereupon the mare owner will immediately remove the mare and pay all costs, fees and expenses outstanding.
5. What the mare is in the custody of the stallion owner the stallion owner shall not be liable for any sickness, disease, injury or death which may be suffered by the mare or its progeny. The stallion owner warrants that all necessary precautions will be taken to ensure the well being of the mare and its progeny. Should the stallion owner be unable to or fail to perform this contract by reason of death or injury or sale of the stallion, all fees paid by the mare owner will be refunded and neither party shall have any rights against the other, under the provision of paragraph 1.
6. **LIVE FOAL GUARANTEE** for the purpose of this contract shall be defined as a foal that stands and nurses. Stallion owner will supply free return the following season if live foal fails to result from the mating. The above is subject to the condition that notification must be made to the stallion owner within 48 hours after time of foaling or aborting, that mare did not produce live foal. A certified veterinarian statement must be received within 14 days of said mares foaling or aborting, giving particulars to substantiate live foal guarantee or live foal guarantee becomes null and void.

7. Mare Owner agrees to book only a mare that is **HALTER BROKE AND GENTLE**.
8. The Stallion owner reserves the right to reject any mare and any amount paid under the provisions of paragraph 1. here of shall be refunded to the mare owner.
9. All transport arrangements and costs shall be the responsibility of the mare OWne1: The mare owner must give at least 24 hours notice to the stallion owner of its intention to deliver or collect the mare. If the mare owner is notified by the stallion owner to collect the mare and fails to do so within 7 days, then the stallion owner may move the mare to such a property of its choosing and all expenses associated will be the responsibility of the mare owner:
10. This contract shall not be assigned or transferred by the mare owner without the written consent of the stallion owner.
11. Pregnancy tests will be carried out by a veterinarian nominated by the stallion owner. If the mare shall be found to be not pregnant then no service fee shall be payable but all other monies herein mentioned shall be paid and this agreement shall in all other respects be performed and observed. The above applies to mares that have not settled by the end of the 20____ Breeding season. The veterinarians certificate of pregnancy examination shall be the property of the mare owner.
12. Stallion service certificates will be issued only at the time that all accounts have been settled and paid in full.
13. Visiting mare's forms will be sent with Breeding Contract. Return ONE for EACH mare on or before time of delivery. A copy of mares registration paper may be sent instead.
14. Artificial Insemination (A.1.) with cool semen is available to the mare owner at designated Veterinary Clinics (approved by the Stallion Owner). All associated insemination costs shall be paid by the mare owner: (For details of estimated costs apply to the Stud Manager). Transport cost of the first shipment of semen from the Stud to the Veterinary Clinic will be met by the Stud and all subsequent shipments by the Mare Owner. The sum of \$200 deposit MUST be paid to the Stud prior to delivery of any semen.

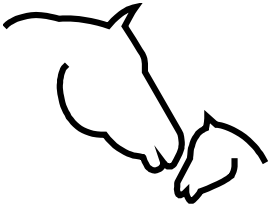

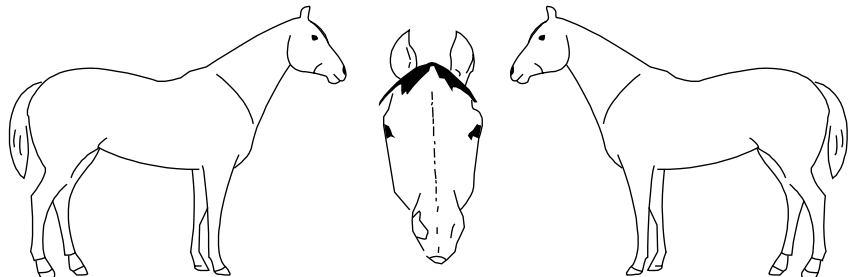
